Revolution is a topical medicine that we use for adults to protect against internal and external parasites. **Advantage II** is used for kittens.

Pyrantel Pamoate is an oral suspension that is given to our kittens to kill round and hookworms at least twice before the kitten goes to a new home.

Panacur liquid is given to eradicate roundworms, hookworms, whipworms, and Giardia.

BREEDER CAT ADDENDUM

The Breeder and Purchaser agree that the clauses below apply to those cats purchased as breeder cats only.

1. This female cat/kitten being sold as a breeder cat will not be bred until AT LEAST twelve (12) months of age and each breeding thereafter will be NO LESS than eight (8) months apart to protect it from being overbred. Failure to abide by this condition shall be considered a breach of the agreement, subjecting the cat/kitten to be repossessed by Breeder in Breeder's sole discretion.
2. This cat/kitten is being sold as a breeder cat and will not have any of its first-generation **male** offspring sold, traded, or exchanged for any other feline or non-feline breeding stock.
3. The first-generation **male** offspring of this cat/kitten may not be sold as a breeder or a show/breeder.
4. Purchaser may use the first-generation offspring in his/her breeding program as per this agreement.
5. The first-generation **male** offspring of this cat/kitten may not be out-crossed to any other feline.
6. This first-generation **male** offspring of this cat/kitten may not be used for stud service.
7. Under no circumstances, will the first-generation **male** offspring of this cat/kitten be sold, leased, or lent for the purpose of breeding any other felines.
8. The offspring from any first generation cat/kitten may be sold as Purebred "Pets" or "Show Quality Alters" to their new adopters and will always be spayed or neutered before being delivered to their new families.
9. Breeder guarantees that a cat/kitten sold as a breeder cat will produce offspring by the second birth date. If the cat should not breed by its second birthday, it may be replaced with a cat of similar kind. Purchaser must provide written proof from a licensed veterinarian showing that the cat has been spayed, or neutered, before a replacement will be given. Breeder holds the right to ensure that a proper pet home is found before any exchanges can be made.
10. The cat/kitten cannot be co-owned, leased, traded, exchanged, or housed in another location other than the cattery to which it was sold.

11. The cat is not to be used in any breeding program after the age of six years unless prior written permission and approval from both the Breeder and a certified veterinarian.
12. Once the Purchaser no longer wishes to use the cat in its breeding program, the Breeder has the first option to readopt the cat. If the Breeder does not wish to readopt the cat the Purchaser must alter the cat and place it in an appropriate Pet Home.
13. This cat may only be bred to Purebred Ragdoll Cats.
14. *The Breeder will have this breeder cat/kitten microchipped at the cost of \$65.00 to the Purchaser. **This is to be scanned and marked on your cat/kitten's veterinarian record each time your cat/kitten is brought to the veterinarian for verification. If this is not done the replacement clause will be null and void.***
15. Failure to satisfy any terms of this addendum will subject Purchaser to a penalty of fifteen thousand (\$15,000) dollars to be paid to Breeder in addition to all other remedies available to Breeder in the Agreement.

SHOW CAT ADDENDUM

1. The show kitten/cat is being sold as a show cat and should be shown at least once as a kitten and as an adult cat. The Breeder asks the Purchaser to show the cat to at least grand champion status in TICA, CFA, CFF, FIFE, or LCWW.
2. The following cat organizations can be used to fulfill this clause: TICA, CFA, LCWW, FIFE, CFF, or any other cat organizations in your area.
3. We hope that the show kitten/cat will be able to achieve at least a Champion or higher status in TICA, LCWW, CFA, CFF, or FIFE.
4. We do understand that there are no guarantees, but it is our hope and desire that this NY Divine Dolls Ragdoll will appear in the show ring.
5. We, of course, hope for the new owners to have the opportunity and joy of Supreming (TICA, LCWW, CFA, CFF, or FIFE) their NY Divine Dolls Ragdoll!
